1. October 31, 1984 Filed Incorporaiton papers
2. December 10, 1984 Obtained certificates of Incorporation from Ohio State Government
  - (a) Xiamen University's U.S. Alumni Association, Incorporated
  - (b) Xiamen University's U.S. Alumni Association, Inc.'s Charitable and Educational Trust
3. September 6, 1985 Obtained Employer I.D. numbers
  - (a) Alumni Association: 34-1484008
  - (b) Trust Fund: 34-1484009

Asked a lawyer to file 501(c)(3) papers
4. August 25, 1986 Asked another lawyer to file 501(c)(3) papers
5. November 3, 1986 Amended the name and combined Trust and Association into one organization, under No. 34-1484008
6. January 22, 1987 Obtained Ohio State Government certificate for new name: "Xiamen University (Amoy University), U.S. Alumni Association, Incorporated"
7. September 30, 1987 Filed 501(c)(3) papers with Internal Revenue Service
8. March 10, 1988 501(c)(3) status approved
9. June 8, 1988 Election process begun
